

Frequently Asked Questions

Inez Demonet Scholarship

1. What are the roles of the AMI and the Vesalius Trust?

A subcommittee of the AMI scholarship committee reviews the Inez Demonet scholarship applications on behalf of the Vesalius Trust.

The Vesalius Trust does not review the applications. The Trust receives the final ranking provided by the AMI Scholarship Committee. Final award announcements come from the Trust.

2. Who provides funding for this scholarship?

Funding for the Inez Demonet Scholarship comes from the Vesalius Trust.

3. Who is eligible for this scholarship?

Any second year student enrolled in a graduate program in medical illustration accredited by the Association of Medical Illustrators is eligible for this scholarship.

4. What are the judging criteria?

Each application will be judged on academic breadth and depth, academic performance, quality of artwork, quality of references and evidence of broad-based interests and accomplishments.

5. Transcripts

What transcripts are required?

a. Both undergraduate and graduate transcripts are required. If you have attended multiple undergraduate or graduate institutions, transcripts from all institutions should be requested.

b. Can I submit an unofficial transcript?

No, all transcripts must be official transcripts.

c. Do you accept electronic transcripts?

Yes, official electronic transcripts are preferred, wherever possible.

6. How will I know that my application has been successfully submitted?

You'll receive an automatic confirmation email when you submit your materials for part A of the application. A short time later, you'll receive a Dropbox invitation to submit your part B materials. Once your part B materials are complete, you'll receive an email from the AMI Scholarship Chair that all your materials have been submitted successfully.

7. Notification

a. When will I find out if I've been chosen to receive the Inez Demonet Scholarship?

You'll be notified by the Trust in late March if you have been selected to receive the award.

b. Will I find out if haven't been selected?

Yes, you'll be notified by the Trust in late March if you *have not* been selected to receive the Inez Demonet Scholarship.

8. Can I get feedback on my application?

We do not offer reviewer feedback on the Inez Demonet Scholarship application.

9. Awards and amounts

a. How many awards are given out every year?

There is one award given each year.

b. How much money does a award recipient receive?

The amount of the award varies and is determined by the Trust, not by the AMI Scholarship Committee.

10. Are there any obligations to fulfill as the Inez Demonet award recipient?

The Inez Demonet recipient is not required to attend the AMI meeting to receive his or her award, however the Trust provides up to \$1,000 US for travel expenses. In addition, the Inez Demonet winner becomes a member of the Board of Directors of the Vesalius Trust for one year following acceptance of the award. The Trust holds their annual meeting in February, and the travel funding may also be used to underwrite attendance for this meeting.
